

TENDER No. CDC/BOB/RDS/13/2018-19- SUPPLY AND DELIVERY OF ROAD MAINTENANCE MATERIALS FOR BOBIRWA SUB DISTRICT COUNCIL

Tender offers are invited for the Supply and Delivery of Road Maintenance Materials for Central District Council (Bobirwa Sub District).

The Procuring Department is Civil and Mechanical Engineering Services Department (Roads Division) - Central District Council (Bobirwa Sub District).

Bidders who are domiciled in Botswana and 100% citizen owned contractors shall, in order to be considered for the award of the contract, be appropriately licensed to manufacture and / or supply such items and be registered with the Public Procurement and Assets Disposal Board (PPADB) in the following categories: **CODE 211: (General Supplies), Sub Code: 19 (Hardware, Tools and Construction Materials) and or CODE: 213 (General Manufacturers/Producers), Sub Code: 07 (Construction Products (including bricks, paving slabs etc)).** Local Authorities Procurement and Asset Disposal Act, 2008 shall apply to the contract. The contract shall be a Frame Work Contract which will run until **31st MARCH 2019** from the date of the contract signing.

Tender documents can be collected from Senior Roads Engineer's **Office No. A28** at Rural Administration Centre (R.A.C), **WING - A**, First Floor, in Bobonong. Documents should be collected during working hours from **07:30 - 12:45** and from **13:45 - 16:30** with effect from **19th February 2018** except for weekends and public holidays.

A non-refundable amount of **P65.00** payable by cash is required prior collection of the tender documents. Youth owned companies will pay 50% of the document price (**P32.50**). Payments shall be made at Revenue Office, Ground Floor, Rural Administration Centre, Bobonong, during work days from **0730 - 1245** and from **1345 to 1530** except on public holidays and weekends.

The closing time for receipt of tender offers is **09:00 hours** on the **16th March 2018**. Opening of Tender will be done immediately after closure of tender on the same day in the Lobby, RAC in the presence of bidders wishing to attend. Late tender offers shall not be accepted. **Tender shall be awarded in packages. No bidder shall be awarded more than one package.**

Telephonic, telegraphic, telex, facsimile or emailed tender offers shall not be accepted.

The Local Authorities Procurement and Asset Disposal Board's Standardised Conditions of Tender apply to the procurement, for which all the applicable Tender Data is contained in the tender documents.

The bidders shall bear all costs associated with the preparation and submission of his tender and Bobirwa Sub District Council hereinafter will under no circumstances be responsible or liable for these costs, regardless of the conduct or outcome of the tender process.

Notwithstanding anything in the foregoing, Central District Council (Bobirwa Sub District) is not bound to accept the lowest or any tender offer.
